ORDER:-

In the reference 1st read above, Government have formulated certain rules for implementation of three language formula in a phased manner from the academic year 2003-04 to the students studying from VI to X classes.

2. In the reference 2nd read above, Government have exempted the students of Oriya speaking Linguistic Minorities in Srikakulam District only from taking Telugu as second Language in classes VI to X in relaxation of G.O.Ms.No.86 Education (SE-C&TBP) Department dt.02-07-2003 and permitted them to study Hindi instead.

3. In the reference 3rd read above, Government have clarified that Telugu shall be compulsory from SSC Public Examinations, March 2009.

4. In the reference 4th read above, the Director of School Education, Hyderabad has requested the Government to issue necessary orders exempting Oriya speaking Students from taking Telugu as Second language and permit them to study Hindi instead in the matter.

5. After careful examination of the matter, Government here by cancel the G.O.Ms.No.63, Education (SE-C&TBP) Department, dt.28.08.2007 and direct the Director of School Education, A.P., Hyderabad to enforce the Three Language Formula as enunciated in G.O.Ms.No.86 Education (SE-C&TBP) Department, dt.02-07-2003 strictly for the batch of students who are in VI class during 2009-10 and VII class during 2010-11, VIII class during 2011-12, IX class during 2012-13 and X class during 2013-14 in all the schools in the state.

6. The Director of School Education, A.P., Hyderabad is also directed that the Oriya speaking students of Srikakulam district appearing X class exam during March/April 2009 shall be exempted from writing Telugu Second Language Exam and permit them to take Hindi instead as they were allowed to study Hindi as Second language in place of Telugu from class VI onwards as per the G.O.Ms.No.63 Education (SE-Exams) Department, dt.28.08.2007.
